Orion Erosion Control Financial Account Agreement

The Orion Erosion Control Financial Account (“Account”) is issued by and credit is extended by Orion Erosion Control, Inc., 3350 Riverwood Parkway, Suite 1900, Atlanta, GA, 30339 or any servicer or financial institution that agrees with Orion Erosion Control to act as issuer and/or servicer of the Account (the “Issuer”). Any references in this Agreement to Orion Erosion Control refer to Orion Erosion Control, Inc. or any Issuer designated by Orion Erosion Control. In this Agreement, the “we” and “us” refer to the Issuer. “You” and “your” refer to the Applicant.

Your use of the Orion Erosion Control Financial Account constitutes acceptance of the following terms and conditions. Use includes the retention or use of the Account by the person named on the Orion Erosion Control Financial Account, authorized users, or anyone under your control, including your employees. Orion Erosion Control Financial Account numbers forwarded to the dealer locations at your request are Account numbers issued to you. The person named on the Orion Erosion Control Financial Account is liable for any unauthorized use of the Account and you agree to be responsible for any unauthorized use. The Orion Erosion Control Financial Account is for business and commercial use only and not for personal, family or household use.

A credit line will be assigned to your Account. This line includes all unpaid purchases, whether billed or unbilled. If, as you use your Account, you find your credit line to be inadequate, please call 1-844-346-2888.

Your account billing cycle is closed on the 15th of the month. Statements are emailed or mailed. Your payment is due on the 1st day of the month (or the next business day if the 1st is a weekend or holiday). Outstanding balances unpaid after the due date will be considered delinquent 10 days after the due date. Delinquent balances will be assessed a finance charge of 1.5% and a \$29.00 late fee per billing period, or, if less, the maximum finance charge and late fee permitted under the law.

You may pay your Orion Erosion Control Financial Account by check, Credit Card Payment, or Electronic Funds Transfer (EFT). EFT authorizes Orion Erosion Control Financial to automatically deduct funds from your chosen bank account. Please notify us if you would like the convenience of paying by EFT.

If your bank should fail to honor payment to Orion Erosion Control Financial, you agree to pay our insufficient funds/returned item fee of \$25.00, or such lesser amount as is required by law. In addition, if your payment is dishonored or your Account becomes delinquent, Orion Erosion Control Financial may require immediate and full payment of all outstanding amounts.

UNDER NO CIRCUMSTANCES SHALL ORION EROSION CONTROL OR ANY OTHER ISSUER BE LIABLE FOR CONSEQUENTIAL, INCIDENTAL, INDIRECT OR PUNITIVE DAMAGES for any claim arising out of or relating to this Agreement.

We reserve the right to change the terms of this Agreement by giving you fifteen days advance notice of the changes. Changes may include, without limitation, additional or different fees and contract provisions. This Agreement will be governed by the laws of the State of Georgia.

In the event that you breach or default under the terms of this Agreement, you will be liable to Orion Erosion Control Financial for all costs and expenses, including late charges and fees and reasonable attorney fees or other costs of collection, incurred by Orion Erosion Control Financial in enforcing its rights here under. You agree that in the event of default in payment, Orion Erosion Control Financial may institute suit against you in the courts of the State of Georgia, regardless of where you are geographically located or conduct business.

You grant us a purchase money security interest in all goods purchased with your Orion Erosion Control Financial Account. Either you or Orion Erosion Control Inc may terminate this Agreement at any time. Payment of all outstanding amounts must be made upon termination.
